	4. Deposit equivalent to one month's rent. The deposit will hold the property ONLY if your application is complete and qualifies. Deposit is payable in the form of money order or cashier's check payable to PPMS, or cash.	
t	5. Application Fee: \$50.00 per applicant 18 yrs and older & \$75.00 per married couple for non-HOA properties. \$75.00 per applicant for CONDOS & other HOA properties. 
